GOVERNMENT OF INDIA HAVE INFORMED THAT AN AMENDMENT HAS BEEN MADE IN ARMS RULES 1962 VIDE HOME MINISTRY NOTIFICATION DATEDS MARCH 28, 1990, PUBLISHED IN GAZETTE OF INDIA EXTRAORDINARY VIDE G.S.R. NO.404 (E)(.) CONSEQUENT TO THIS AMENDMENT FOLLOWING CHANGES HAVE BEEN MADE IN RESPECT OF GRANT/RENEWAL OF ARMS POSSESSION LICENCES FOR NON-PROHIBITED WEAPONS:-

- 1) DISTRICT MAGISTRATE CAN GRANT LICENCES VALID FOR DISTRICT/STATE (.)
- 2) STATE GOVT. CAN GRANT LICENCES VALID FOR ALL COVER INDIA OR ANY SPECIFIED PART THEREOF (.)
- 3) DISTRICT MAGISTRATE CAN RENEW ALL LICENCES VALID FOR DISTRICT/STATE/WHOLE OF INDIA(.)

COPY OF GOVERNMENT OF INDIA SAID NOTIFICATION AWAITED WHICH WILL BE SENT TO YOU WHEN RECEIVED TOGETHER WITH REVISED INSTRUCTIONS, IF ANY, IN REGRD TO SANCTION OF NEW LICENCES KEEPING IN VIEW THE ABOVE AMENDMENT MEANWHILE ACTION MAY BE TAKEN WITHIN THE PARAMETERS OF ARMS ACT AND RULES AS UNDER :-

1. DISTRICT MAGISTRATES MAY GRANT NEW LICENCES FOR N.P. BORE WEAPONS VALID FOR DISTRICT, STATE TO CATEGORIES OF APPLICANTS SPECIFIEDS IN G.O. NO. 1459-R/VI-P-5-2 A.O./90, DATED MARCH 23, 1990.
2. DISTRICT MAGISTRATES MAY RENEW N.P. BORE WEAPON LICENCES VALID FOR DISTRICT/ STATE/WHOLE OF INDIANIN ACCORDANCE WITH AMENDMENT ARMS RULES DATED MARTH 28, 1990. NO. REFERENCE NEED BE MADSE TO STASTE GOVT. AND/OR GOVT. OF NDIA FOR CONCURRENCE (.)
3. WHILE GRANTING / RENEWING LICENCES INSTRSUCTIONS CONTAINED IN PARA 9 OF GOVT. OF INDIA LETTER NO.V-11026/8/89 ARMS FATED JULY 4, 1989 (ENCLOSED WITH G.O.NO.G.I.35 R/VIII-5-126-87 T.C. DATED 27.9.89) BE KEPT IN VIEW.
4. PERIODIREVIEW OF EXISTING SEMI-AUTOMATIC / PROHIBITED BORE/NPN-PROHIBITED BORE LICENCES BE CONDUCTED AND LICENES MAY BE CANECLLED OR THEIR JURISDICTION CURTALLED OR BE REPORTED TO GOVT. FOR CANCELLANTION /CURTAILMENT, AS THE CASE MAY BE, ON THE BASIS OF SUCH REVIEW.
